

# Miles College Residence Hall Fine Policy



Students may receive fines for violations of residence hall policies including, but not limited to, the following:

Absence from mandatory residence hall meetings	\$50.00 (without an excuse) <b>**FOR EACH OFFENSE**</b>
Loud music/TV	\$25.00 (after 1 <sup>st</sup> violation) \$50.00 (2 <sup>nd</sup> violation) <b>*TERMINATION OF HOUSING CONTRACT* (3<sup>rd</sup> violation)</b>
Hanging clothes, towels, etc., in or outside residence hall windows	\$50.00
Tampering with/removing light bulbs from hallway	\$50.00
Playing with security cameras Playing with fire extinguishers	\$200.00 \$200.00
Standing near residence hall windows indecently exposed or wearing undergarments	<b>**SUSPENSION FROM RESIDENCE HALL**</b>
Use of profanity	\$50.00 (1 <sup>st</sup> violation) <b>continued use will result in termination of housing contract</b>
Furniture Misappropriation (moving dorm room furniture)	\$50.00
Failure of room inspection violation	\$25.00 (1 <sup>st</sup> violation) \$50.00 (2 <sup>nd</sup> violation) <b>**TERMINATION OF HOUSING CONTRACT** (3<sup>rd</sup> violation)</b>
Temporary access lock-out	\$50.00 (1 <sup>st</sup> Violation) \$150.00 new key fee (after 24hrs key not accessed)
Excessively dirty room at check-out	\$100.00
Tampering with/destroying locks on doors	\$150.00
Violation of illegal dorm visitation	\$500.00 (1 <sup>st</sup> violation) (2 <sup>nd</sup> violation) <b>*TERMINATION OF HOUSING CONTRACT*</b>
Possession of alcohol in dorm room/parking lots Under the influence	\$200.00 (1 <sup>st</sup> violation) <b>TERMINATION OF HOUSING CONTRACT</b>
Possession of illegal substances Under the influence of illegal substances	<b>\$500.00 (PLUS IMMEDIATE TERMINATION OF HOUSING CONTRACT)</b>
Repairs for clogging sinks and toilets in residence halls Destruction of residence hall property	(Labor costs and repairs for destruction of residence hall property such as: toilets, sinks, water fountains, fire alarms, smoke detectors, thermostats, etc.) (Replacement cost of property will be subject to the current market price)
Insubordination to residence hall personnel	\$200.00 (1 <sup>st</sup> violation) <b>*TERMINATION OF HOUSING CONTRACT* (2<sup>ND</sup> Violation)</b>
Using grill or hot plate, burning candles, incense, or using George foreman grill inside residence hall	\$100.00 (1 <sup>st</sup> violation)  <b>*TERMINATION OF HOUSING CONTRACT* (2<sup>ND</sup> Violation)</b>
Opening, hanging/talking out of residence hall windows	\$50.00
Entering/exiting emergency doors	\$100.00
Lost key	\$150.00 (charge per lost room key)
