ADVERTISEMENT AND NOTICE FOR BIDS

Sealed bids will be received by TALA Professional Services on behalf of Miles College, located at 5500 Myron Massey Blvd., Fairfield, AL 35064, on the 16th day of November, 2022, until 2:00, pm., o'clock, local time.

Award of the contract will be made within thirty (30) calendar days from the date of the bid opening.

1. The Project:

A. The Project shall be known as **Miles College – Security Camera System and** the general character of said project shall consist of the following:

Provision, installation, termination, testing, labeling, and documentation of a complete security camera system and required hardware on the Miles College Campus located at 5500 Myron Massey Blvd. Fairfield, Alabama 35064.

B. The approximate quantities of said Project can be determined from technical specifications, location spreadsheet and site survey.

C. Special instructions are as follows: the bidders MUST provide a copy of their general contractor license and City of Birmingham / Fairfield business licenses with their bid/proposal response; the bidders MUST acknowledge in writing that all materials and labors included in the specifications, spreadsheets, and required to provide a completely functional and operational security camera system are included in their price ; bidders MUST include in their bid response a list of all subcontractors that will used on the project; and the bidder MUST include the completed itemized pricing sheet in their bid/proposal response

D. The College will furnish the following: IT rooms and equipment racks / cabinets space if available; data switch ports if available and electrical power.

E. Time of Construction: From the date stated in the Notice to Proceed, the Project time of installation is 90 consecutive calendar days.

2. Plans and Specifications:

3. Qualification of Bidders:

- A. All bidders must be responsible, meeting the criteria and requirements set forth in the Instructions to Bidders and bid proposal.
- B. **Prequalification of Bidders IS ; IS NOT required.**

If prequalification of bidders is indicated to be required by the preceding sentence, then written prequalification information is available for review at the same office where plans, specifications and Contract Documents are available.

- C. The attention of all bidders is called to the provisions of State law governing "general Contractors," as set forth in Ala. Code §34-8-1, et seq. (1975), and rules and regulations promulgated pursuant thereto.
- D. If a construction manager is being utilized and this contract is one of a multiple of trade contracts, then the bidder shall be fully licensed for the trade, as determined by applicable law.
- E. The College may not enter into a contract with a non-resident corporation or entity which is not qualified under State law to do business in the State of Alabama.
- F. All bidders shall possess all other licenses and/or permits required by applicable law, rule or regulation for the performance of the work.
- G. All bidders must submit with their proposal, Contractor's license number and a copy of the license. State law, Ala. Code §34-8-8(b), requires all bids to be rejected which do not contain the General Contractor's current license number.
- H. The College reserves the right to reject all bids and/or reject and rebid the Project should it determine the same is in the best interest of the College.

4. Construction Manager:

_____ If the preceding blank is marked with an affirmative indication, it means that this contract involves the use of a construction manager and this contract is one of several multiple trade and/or multiple prime contracts for work on the Project. Bidders attention is called to the supplemental conditions attached to the General Conditions of the Contract Documents regarding this topic, if provided.
